That clause 4 of Bill 11 be amended in the English version of proposed subsection 307.93(2) by striking out "other information" and substituting "information".

The motion was carried. The Minister of Infrastructure concurred.

#### MLA Morse moved:

That clause 6 of Bill 11 be amended by deleting proposed subsection 311.2(3) and substituting the following:

(3) Personal information may only be disclosed, in respect of an application made under subsection (1), if

(a) the Registrar is satisfied that the research or statistical purposes for which the information is sought cannot reasonably be accomplished unless the information is provided in individually identifiable form; and
(b) an information sharing agreement between the Registrar and the public body making the application is in effect.

The motion was carried. The Minister of Infrastructure concurred.

#### MLA Reid moved:

That clause 6 of Bill 11 be amended by adding the following after proposed subsection 311.2(7):

(8) For greater certainty, subsection 49(1) of the Access to Information and Protection of Privacy Act applies to this section.

The motion was carried. The Minister of Infrastructure concurred.

Chair Hawkins moved that clause 7, clause 8 and clause 9 be accepted as presented in draft Bill 11. The motion was carried.

MLA Morgan moved that Bill 11: An Act to Amend the Motor Vehicles Act be reported to the Assembly as ready for consideration by Committee of the Whole, as amended. Carried
