Speaker's Rulings

The Honourable Frederick Blake Jr., Speaker, delivered a ruling on the point of privilege under Rule 20 of the Rules of the Northwest Territories, raised by Mr. Jackson Lafferty, Member for Monfwi, on February 27, 2020. Finding no prima facie breach of privilege, the point of privilege was dismissed.

The Speaker delivered a ruling on the point of order under Rule 24 of the Rules of the Northwest Territories Legislative Assembly, raised by the Honourable R. J. Simpson, Government House Leader, on February 27, 2020. Finding there was a point of order, the Speaker asked the Member for Monfwi to withdraw his comments and apologize to the House


Committee Motion 6-19(2)
