**DECISION PAPER
AMENDMENT TO SCHEDULE C
LEGISLATIVE ASSEMBLY AND EXECUTIVE COUNCIL ACT**

PROBLEM

On April 1st of each year, Member's indemnities and allowances, as set out in Schedule C of the *Legislative Assembly and Executive Council Act*, are deemed to be adjusted by the percentage increase or decrease in the Consumer Price Index. The Board of Management is obligated under Section 21(2) of the *Act* to amend Schedule C by way of regulation to reflect the adjustment required. The Board of Management must recommend that the amendment to the Regulations be made by the Speaker.

RECOMMENDED DECISION

That the Board of Management directs the Speaker to amend *Schedule C Amendment Regulations* to the amounts reflected in the attachment.

BACKGROUND

The *Legislative Assembly and Executive Council Act* describes indemnities and allowances for which Members of the Legislative Assembly may be eligible. Schedule C of the *Act* sets out the actual monetary value of certain indemnities and allowances provided to Members.

Further, the *Legislative Assembly and Executive Council Act* states in Section 21(2) that the amounts set out in Schedule C are deemed to be adjusted each year on the first day of April and in accordance to the percentage increase or decrease of the Consumer Price Index, between the previous calendar year and the year prior to that. The CPI as calculated is .7%. Section 21(2) goes on to require that the Board of Management amend Schedule C, by way of regulation, to affect the adjustment necessary.

This will be done by way of *Schedule C Amendment Regulations*, which came into force in 2005. This amendment was drafted to allow for the adjustment related to the Consumer Price Index to be made annually, up to and including April 2008. However, a major review of the *Legislative Assembly and Executive Council Act* resulted in amendments to the *Act*, which was effective October 1, 2007. These amendments necessitate a consequential amendment to the *Schedule C Amendment Regulations*

REGULATIONS, 2021**

The Legislative Assembly Board of Management, under section 21 of the *Legislative Assembly and Executive Council Act* and every enabling power, makes the *Schedule C Amendment Regulations, 2021*.

1. Schedule C of the *Legislative Assembly and Executive Council Act* is amended by these regulations.

2. (1) Part 1 is amended by striking out "\$109,991" and substituting "\$110,761".

(2) Part 2 is amended by striking out

- (a) "\$83,656" in paragraph (a) and substituting "\$84,241";**
- (b) "\$58,869" in paragraph (b) and substituting "\$59,281";**
- (c) "\$47,875" in paragraph (c) and substituting "\$48,210";**
- (d) "\$7,746" in paragraph (d) and substituting "\$7,800";**
- (e) "\$4,649" in paragraph (e) and substituting "\$4,682";**
- (f) "\$6,863" in paragraph (f) and substituting "\$6,911";**
- (g) "\$10,113" in paragraph (g) and substituting "\$10,184";**
- (h) "\$3,432" in paragraph (h) and substituting "\$3,456"; and**
- (i) "\$3,432" in paragraph (i) and substituting "\$3,456".**

(3) Part 3 is amended by striking out "\$7,926" in each of paragraphs (a) and (b) and substituting "\$7,982".

DECISION PAPER
AMENDMENT TO THE
INDEMNITIES, ALLOWANCES AND EXPENSE REGULATIONS

PROBLEM

The maximum amount payable to Members for expenses related to constituency work is set out in the *Indemnities, Allowances and Expense Regulations* which fall under the *Legislative Assembly and Executive Council Act*. This schedule is deemed to be adjusted according to the Consumer Price Index (CPI) on April 1 of each year. The Board of Management must recommend that the amendment to the Regulations be made by the Speaker.

RECOMMENDED DECISION

It is recommended that the Board of Management direct the Speaker to amend the *Indemnities, Allowances and Expense Regulations* to the amounts reflected in the attachment.

BACKGROUND

The Speaker, on the recommendation of the Board of Management and under the authority of Section 43 of the *Legislative Assembly and Executive Council Act*, enacts regulations setting out the maximum amounts allowable to Members under the Constituency Work Expense Allowance.

These amounts are deemed adjusted on April 1 of each year by the percentage increase or decrease in the CPI between the last two calendar years. This increase of .7% is reflected in the attached amendment to the Regulations.
