# Consideration in Committee of the Whole of Bills and Other Matters

The Chair, the Member for Inuvik Twin Lakes, reported that the Committee of the Whole considered Committee Report 32-19(2): Standing Committee on Rules and Procedures Report on the Chief Electoral Officer's Auxiliary Report: Issues Arising from the 2019 Territorial Election, and reported progress with eight motions carried.

### Committee Motion 254-19(2)

The Member for Hay River South moved the following motion:

I MOVE that this Committee recommends that Elections NWT trial a vote anywhere model during advance voting in the offices of the returning officers;

AND FURTHER, that any necessary legislative amendments that are required to allow such a model be made.

The motion was CARRIED.

#### Committee Motion 255-19(2)

The Member for Hay River South moved the following motion:

I MOVE that this Committee recommends that the *Elections and Plebiscites Act* be amended to remove the requirement to publish a candidate's or official agent's residential address under sections 96 and 97, and to substitute community of residence.

The motion was CARRIED.

Committee Motion 256-19(2)

The Member for Hay River South moved the following motion:

I MOVE that this Committee recommends that the *Elections and Plebiscites Act* be amended to allow Elections NWT to create a register of future electors, allowing youth aged 16 and 17 years old to register with the same information as permitted under s. 54(2) of the *Act*.

The motion was CARRIED.

Committee Motion 257-19(2)

The Member for Hay River South moved the following motion:

I MOVE that this Committee recommends that in implementing an election rebate program authorized under the *Elections and Plebiscites Act*, the Chief Electoral Officer ensure candidates are not able to claim a rebate for any money they donated to their own campaign that is also eligible for a tax credit from the Canada Revenue Agency.

The motion was CARRIED.

Committee Motion 258-19(2)

The Member for Hay River South moved the following motion:

I MOVE that this Committee recommends that references to "polling station account" be removed from the *Act* and that a provision be added to section 119(4) that requires any deputy returning officer who appoints a peace officer to state their reasons for doing so in writing to the returning officer as soon as possible.

The motion was CARRIED.

Committee Motion 259-19(2)

The Member for Hay River South moved the following motion:

I MOVE that this Committee recommends that section 205(e) of the *Elections* and *Plebiscites Act* be amended to require that a returning officer include in their report of proceedings any appointments of peace officers made under s. 119(4) of the *Act*.

The motion was CARRIED.

Committee Motion 260-19(2)

The Member for Hay River South moved the following motion:

I MOVE that this Committee recommends that the *Elections and Plebiscites Act* be amended to allow an Electoral Boundaries Commission to receive information from the register of electors under section 77.

The motion was CARRIED.

**Committee Motion 261-19(2)** 

The Member for Hay River South moved the following motion:

I MOVE that this Committee recommends that the *Elections and Plebiscites Act* be amended to allow for a candidate's financial report to be submitted within 45 business days rather than 60 calendar days.

The motion was CARRIED.

The Member for Inuvik Twin Lakes, seconded by the Member for Deh Cho, moved concurrence of the report of the Committee of the Whole. The motion was CARRIED.

The Speaker adjourned the House at 4:10 pm.
