




Funding for French Language Communications and Services

Misleading Comparisons between French and Indigenous Languages




French and Indigenous Languages in the NWT have many similarities:


- Both have their histories
- Both have their challenges
- Both fight valiantly to keep their languages and culture alive and vibrant in the NWT

But French and Indigenous languages also have significant differences in that:

- French focus is on services
- History of language and cultural erosion: more apparent and profound for Indigenous languages
- Revitalization for the 9 NWT Indigenous languages is the main current priority




GNWT Approach to Indigenous Languages











GNWT Approach to Indigenous Languages (con't)

| PROGRAMS AND RESOURCES | Develop community capacity in Indigenous language revitalization. | Develop the resources and capacity to deliver services in Indigenous languages. |

NWT Indigenous Languages
Framework (2017) outlines the
GNWT's vision into two over-arching
goals:

- Indigenous Languages Revitalization
- Indigenous Languages Access (Service Delivery)

NWT Indigenous Languages Action Plan (2018-2022) acts as a 4-year blueprint for Indigenous languages and education initiatives in the NWT:

 17 action items that outline the deliverables in six priority areas / measures of success



Federal Indigenous Languages Act – Implications for NWT OLA

- The first ever federal *Indigenous Languages Act* (ILA) was put into law in 2019.
- The federal government is in the consultation phase leading up to the appointment of the new Commissioner for Indigenous Languages.
- The impacts on our current arrangements with the federal government remain unknown.



Recommendations for Amendments to OLA

1. Improve functioning of the language boards

2. Update language of the legislation

3. Revise regulations and guidelines for Indigenous languages
