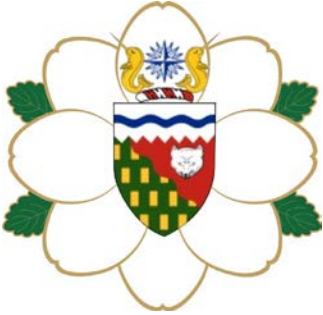


Nomination Form



Order of the Northwest Territories

The Order of the Northwest Territories was established in 2013 by the *Territorial Emblems and Honours Act* to recognize individuals who have served with the greatest distinction and excelled in any field of endeavour benefiting the people of the Northwest Territories or elsewhere. It is the highest honour awarded to residents of the Northwest Territories.

Canadian citizens who are current or former residents of the Northwest Territories are eligible to receive the Order and can be nominated by an individual or organization. A maximum of ten people may receive the order in the first two years and up to three per year in subsequent years. Is your nominee eligible?

Please review and acknowledge the following:

- The nominee is a current or former resident of the NWT, who has served with the greatest distinction in any field of endeavour benefiting the people of the NWT or elsewhere.
- The nominee is not an elected representative (Federal, provincial, territorial and municipal elected representatives are not eligible for appointment to the Order while they remain in office.)
- The nominee is not an elected leader of an aboriginal government (example: band leaders of aboriginal governments are not eligible for appointment to the Order while they remain in office.)
- The nominee is not a judge (judges of any court of any territory or province of Canada are not eligible for appointment to the Order while holding office.)
- The nominee is not the same person as the nominator (Self-nominations will not be accepted.)
- The nomination is not for a group or organization (The Order cannot be bestowed upon an organization.)
