Elections NWT conducts and administers general elections, by-elections, and plebiscites in the Northwest Territories. Its principal mandate is to educate, inform and empower all eligible electors and candidates in the Northwest Territories to exercise their democratic rights outlined in the Canadian Charter of Rights and Freedoms, so that they may participate fully in the election process.

OFFICE OF THE HUMAN RIGHTS COMMISSION

The Human Rights Act came into force on July 1, 2004. The Act recognizes that in the Northwest Territories every individual is free and equal in dignity and rights, without regard to their race, colour, ancestry, nationality, ethnic origin, place of origin, creed, religion, age, disability, sex, sexual orientation, gender identity, marital status, family status, family affiliation, political association or social condition and without regard to whether he or she has had a conviction for which a pardon has been granted.

The Standing Committee on Accountability and Oversight is the body where all 11 Regular Members come together to coordinate sessional business and Committee strategic initiatives. This Committee also reviews issues which have government-wide implications.



Committee held 55 meetings between April 2022 and March 2023. During this fiscal period, Committee was satisfied with its unified efforts to negotiate additional funding for important initiatives in the 2023-

2024 budget: namely, the sustainable livelihoods fund;

emergency response; Non-Government Organizations inflationary increases; the Support for Entrepreneur and Economic Development (SEED) program; mental wellness and aftercare; youth, sport and recreation; and homelessness prevention.

Committee also held a public meeting on February 10, 2023 with the Premier on the subject of how the Government planned to implement the United Nations Declaration on the Rights of Indigenous Peoples.

The Standing Committee on Government Operations considers matters pertaining to these Departments: Executive and Indigenous Affairs, Finance, Municipal and Community Affairs, as well as the Northwest Territories Power Corporation, and the Workers Safety and Compensation Commission.

The other responsibilities of the Committee include performing reviews of annual reports released by the Statutory Officers of the Legislative Assembly, the Government of the Northwest Territories

Public Accounts, and the Auditor General of Canada.

In their final year, Committee completed reports on the priorities they set for themselves: Increasing Indigenous representation in the Public Service and Official Languages.

This process began with public consultations in-person when possible, and via ZOOM as necessary. To ensure they performed thorough reviews Committee held internal briefings with the Departments, followed by public briefings prior to travelling into communities and meeting with the public.

By years end Committee fulfilled their responsibilities as mandated by the 19th Assembly, and completed their initiatives. After forty nine (49) meetings Committee's hard work culminated in the following reports:

The Standing Committee on Social Development is mandated to consider matters with respect to the Departments of Education, Culture

and Employment; Health and
Social Services; Justice; and
Housing Northwest Territories.
Their responsibilities include
reviewing performance and
multi-year business plans on
budgets, bills, boards and
agencies. This also includes
the Status of Women Council,
programs for seniors, youth, and
persons with disabilities, homelessness
and any matter referred by the House.

Committee's priority for the 19th Assembly was set to increase and improve housing stock as well as access to housing according to the needs identified by Northwest Territories residents. Throughout the Assembly, committee has continually engaged with the public,

held public meetings and accepted submissions to address Housing needs.

Committee held 56 meetings during this fiscal year and submitted two committee reports. On March 7, 2023, Committee released their report on Homelessness

Prevention – Supporting Pathways to Housing NWT Residents. The focus of the study was homelessness prevention, this refers to targeted policies, practices and interventions that prevent a person from experiencing homelessness or reducing the

risk of homelessness recurring. Prevention is key as it also provides the necessary resources, supports and other integrated services as a pathway out of homelessness. Committee made 18 recommendations to various departments with the intention of preventing or reducing the number of NWT residents who may

experience homelessness in the future, and interventions for those who are currently experiencing homelessness.




RECOMMENDATIONS

56 MEETINGS

In October 2022, the Office of the Chief Coroner released the 2021-2022 Early Release of Suicide Data to raise alarm on the upsurge of deaths to suicide. On March 27, 2023, the Standing Committee on Social Development released their Report on Lifting Youth Voices: Recommendations on Suicide Prevention. Committee took two approaches to this report, suicide prevention which focused on strategies that reduce the loss of life to suicide, and a trauma informed approach that recognizes a person holistically and acknowledges that a person may have or is currently experiencing trauma.

Committee had 4 Bills referred to them, reviews were completed and reports released on the following:



- Interim Report on Bill 65: Builders' Lien Act
- Report on Bill 48: Arbitration Act
- Report on Bill 40: An Act to Amend the Medical Profession Act

Following their review,
Committee made 11
recommendations some
of which were regarding
prevention, mental health and
wellness, aftercare, addictions
support, healing and housing.

5 MEETINGS

The Standing Committee on Rules and Procedures met five times and produced one written report between April 2022 and March 2023.
Committee presented its report titled "Report on the Chief Electoral Officer's Auxiliary Report: Issues Arising

from the 2019 Territorial Election" to the House on October 13, 2022.

This work stemmed from Committee's February 2021 Report on its review of the CEO's Report on the Administration of the 2019 Territorial General Election; in Committee's Report, it directed the CEO to conduct additional research on some outstanding matters and report back to the Legislative Assembly.

On March 29, 2022, the Speaker tabled the results of the CEO's research in his Auxiliary Report of the Chief Electoral Officer: Issues Arising from the 2019 General Election.

After careful review of the CEO's newest report,
Committee's report contained a total of eight recommendations to streamline future elections. The recommendations address areas of concern brought up by the Chief Electoral Officer as well as the Electoral Boundaries Commission.

The Special Committee on Reconciliation and Indigenous Affairs (Committee) was created on October 29, 2020. Committee was mandated to seek and encourage discussion and recommendations with respect to opportunities and challenges in meeting the Assembly's priorities on land negotiations, self government agreements and implementing the United Nations Declaration on the Rights of Indigenous Peoples (UNDRIP).

In December 2020, Canada released a proposal for legislation to implement the UNDRIP and passed it into law in June 2021.

Canada replaced the Comprehensive
Land Claims Policy with the paradigm of
co-development for Crown-Indigenous
dialogue. Canada aims to increase flexibility
in negotiations and respond to Indigenous
nations' rights, needs and interests. The federal
government indicated removing final settlement
language and replacing rights extinguishment
clauses with flexible agreements.

With the process for negotiation agreed upon in advance in co-developed Memoranda of Understanding and Framework Agreements.

The Special Committee began its work on December 4, 2020, and heard from legal experts, scholars, researchers, Government of the Northwest Territories, Federal Government and Indigenous governments and

nations. Witnesses locally and nationally met predominately virtually, with Committee, to share their perspectives.

Committee held five meetings during their last year with a total of 26 in all.

The Committee published their Final Report: A Northwest Territories

Approach to the United Nations Declaration on the Rights of Indigenous Peoples and Negotiating Agreements (February 28, 2023).

Within 32 meetings in the fiscal year, the
Standing Committee on Economic Development and Environment (SCEDE) reviewed two pieces of legislation and focused its effort

on its priority to ensure the Northwest Territories is well positioned to prevent environmental liabilities, effectively manage contaminated sites, and stimulate local economic opportunities through remediation.

SCEDE was also pleased to visit Whati in the summer of 2022 to speak with residents about community concerns regarding the economy and environment.

On May 26, 2022, **Bill 46**: An Act to Amend the *Motor Vehicles Act* was reported back to the House by Committee as ready to proceed to Committee of the Whole.

SCEDE reviewed Bill 53: Elevators and Lifts Act and read a report on its review in the House on October 18, 2022.

The second report produced by SCEDE during the fiscal year was titled "Report on the Prevention and Management of Contaminated Sites." Read in the House on February 7, 2023, the report advances work on the Committee's priority regarding contaminated sites. The report contained 16 recommendations to the remment of the Northwest Territories regarding

Government of the Northwest Territories regarding contaminated sites in the NWT.

In March 2023, three bills were referred to SCEDE for review:

Bill 74: Forest Act.

Bill 78: Waste Reduction and Resource Recovery Act.

Bill 84: An Act to Amend the *Northwest Territories Business Development and Investment Corporation Act.*

Bill 74: Forest Act will be a notably different review process, as it will be the first co-drafted resource management bill to make its way through the legislative process in the House under a newly signed process convention for reviewing co-drafted bills.

The Board of Management (the Board) is a corporate body established under the *Legislative Assembly and Executive Council Act*. The existence of the Board reflects the right and privilege of the House to govern its internal affairs and confirms the independence of the Assembly from the executive branch of government.

The Board is responsible for the overall management and administration of the Legislative Assembly, including the provision of services to Members and the establishment of policies regarding their conduct.

The composition of the Board includes the Speaker, two Members of the Executive Council, and two Regular Members.







OFFICE OF THE CLERK

The Clerk of the Legislative Assembly is entrusted with the authority, responsibilities, and functions to that of a Deputy Minister, charged with the management and administration of the Legislative Assembly, in accordance with the terms outlined in the *Public Service Act* and the *Financial Administration Act*.

New Clerk Appointed

The Speaker, Frederick Blake Jr., welcomed the appointment of Glen Rutland as the new Clerk of the Northwest Territories Legislative Assembly. This appointment was approved by the Legislative Assembly, on April 1, 2023.

Mr. Rutland's public service career and his expertise in parliamentary law and procedure span more than 20 years. Mr. Rutland served as the Deputy Law Clerk, Law Clerk, and Deputy Clerk, House Procedure and Committees at the Assembly.

The Speaker thanks Mr. Tim Mercer for his dedicated service as Clerk of the Northwest Territories since 2003. During his tenure as Clerk, Mr. Mercer showed exemplary leadership in the House, to the benefit of all Northerners. Mr. Mercer served six legislatures and presided over five transitions of Government. He served two terms as President of the Association of Clerks at the Table in Canada and is widely recognized as an expert on parliamentary procedure and consensus government.

The much-anticipated Kindergarten Christmas Program of 2022 marked a successful return to the planning observed before the onset of COVID-19. After several years of closure to the public due to pandemic-related restrictions, the Legislative Assembly building once again opened its doors to the enthusiastic students. This event, eagerly awaited by students, schools, and Assembly staff alike, has been a cherished tradition since the inauguration of the Legislative Assembly building in 1993.

Each year, the Assembly extends invitations to kindergarten classes from Dettah, Ndilo, and Yellowknife to participate in the festive occasion, adorning a Christmas tree in the Great Hall.

In the year 2022, the program witnessed the enthusiastic participation of 276 students from 9 schools, resulting in the decoration of 13 trees in the Great Hall. The kindergarten students showcased their creativity by crafting homemade Christmas decorations for the Legislative Assembly.

Upon completion of the decoration process, as the Great Hall shimmered with the glow of Christmas trees and ornaments, captivating staff, and visitors instilling a profound sense of Christmas spirit.





Annually, the Northwest Territories Legislative Assembly offers a unique opportunity for students in grades nine and ten from across the Northwest Territories to travel to Yellowknife to take on the role of an elected Member and participate in the daily workings of consensus government at the Legislative Assembly.

Nineteen students are chosen from each electoral district to assume the role of their MLA. Each parliamentarian participates in specific duties like research, writing a Member's/ Minister's statement, and taking part in debate. The end goal was to hold a mock session in the chamber where they take what they have learned and apply it to have their voice heard by the people of the Northwest Territories in a mock sitting.

Youth Parliament 2022 took place on May 8-13, 2022, and Youth Parliament 2023 took place on April 16-21, 2023, in Yellowknife. Both events were successful but took two different approaches. The 2022 edition, was restored quickly after the COVID-19 restrictions were lifted, therefore, planning for this event was similar to past years, where a cabinet was formed and the group of regular members. During 2023, a new approach was established to learning about our unique government. Instead of being separated into two groups, all the youth parliamentarians stayed as one large group and learned all the same things, at the same pace.

MACE TOUR

Annually, the Speaker and some of the staff of the Legislative Assembly embark on a community tour with the Mace, eager to share its history and significance. The Mace honours the vibrant culture of the Northwest Territories by bringing together northern elements, painting, carving, metalwork, beadwork, quillwork, and pebbles from each of the 33 communities.

In April 2023, the Speaker of the House Frederick Blake Jr, took the mace on a tour of a couple NWT communities. However, upon reaching his hometown of Tsiigehtchic, Mr. Blake found the path to his home community blocked.

When the only road into town is blocked and you need to continue the Official NWT Mace tour, you just have the Honourable Speaker snowmobile it into town by sled. Ensuring the Mace's journey remained uninterrupted.

INSPIRED BY NATURE, REFLECTED IN LANGUAGE

The Northwest Territories Legislative Assembly celebrated Indigenous Languages Month (February) by unveiling the renaming of its meeting rooms in the territory's nine Indigenous languages.

The Legislative Assembly's meeting room re-naming project which was inspired by nature and reflected in language. The project includes representation of all Official Languages and regions in the Northwest Territories. Each of the nine rooms chosen is represented by a northern animal, and the name and description has been translated into one of Indigenous languages as well as French. Illustrations were done by an NWT-born Indigenous artist, Trey Madsen and symbolize the traits associated with each animal, bringing deeper meaning to the work that takes place in each meeting room.

All Members, staff and the public are encouraged to use the translated room names to integrate Indigenous languages into everyday work.


