

Committee Transition Overview and Considerations



Standing Committee on Accountability and Oversight

The eleven Regular Members of the Legislative Assembly comprise the Standing Committee on Accountability and Oversight. The committee's role is to:

- A. Review issues which have government-wide implications, including all issues related to Devolution implementation, and the overview of the budget and fiscal framework;
- B. Review Government of the Northwest Territories reports on financial and performance results and program and policy evaluations to ensure anticipated outcomes are being achieved and accountability is maximized;
- C. Coordinate Sessional business scheduling and planning in cooperation with appropriate Ministerial representatives;
- D. Coordinate Committee public consultation efforts with respect to budget and fiscal matters;
- E. Coordinate Committee strategic planning efforts;
- F. Monitor and evaluate Ministerial performance issues;
- G. Consider issues related to land claims and self-government negotiations;
- H. Consider issues related to public engagement and transparency efforts by standing and special committees;
- I. Consider issues related to federal and international relations;
- J. Consider the budgets and financial management of any boards and agencies that are outside the responsibility of any Standing Committee; and
- K. Consider any other matter referred by the House.

Recommendations for follow-up in the next assembly:

The 20th Assembly's AOC should consider the following committee priorities and processes from the last Assembly:

- Collaborative Efforts in Budget and Policy Negotiations
 - Committee wished to highlight the successes in policy and budget negotiations seen through AOC. The 19th Assembly has seen Regular Members and Executive Council work well together compared to other assembly. This is further supported by the collaboration seen amongst members of AOC.
 - Committees wishes to highlight those collaborative efforts, particularly with budget negotiations, was both in the ability of Committee to add funding and subtract funding throughout the capital and operational budgets. This was through true consensus amongst policy goals that Committee was able to work through and engage with the government on.
 - Through a more collaborative process AOC was able to advocate for an additional \$30million is operational and capital spending over the course of the Assembly while simultaneously advocating for new policy direction and focus of the government in a variety of areas. Some of these improvements included important supports to municipal governments, mental health and additions programming, focus on the affirmative action policy update, support for homeless shelter funding, increasing the tobacco tax rates, funding for on the land programming, and a new and more accurate way of spending capital dollars.
 - Committee is also responsible for additional benefits to evacuees during the wildfire season of 2023. Through collaboration and united action, Committee was able to increase the overall supports provided to residents who were evacuated from their homes and to businesses who faced closures due to natural disasters.
- Policy on Attendance and Participation by Video and Phone Conference
 - o In the Winter of 2019, AOC confirmed their Video and Phone Conference Policy. This Policy allowed for the ability of Members to dial into Committee meetings virtually. The policy was timely given the COVID-19 Pandemic and highlighted how a balance between in-person and virtual is key to ensure Committee business can continue at a meaningful pace.
 - Although Committee weeks are still seen as necessary as a great deal of work is completed in those weeks, the ability to have shorter and more frequent meetings through virtual participation gives flexibility to Committees and how they conduct their business.
- Consensus Government Process Convention
 - Although only one Bill has now moved through the Consensus Government Process Convention, Committee hopes to see more partnership between Committee, the Government, and Indigenous



Governments to ensure this process is better streamlined and collaborative.

 Committee encourages a strong working relationship through all partners in an effort to ensure this process as efficient and effective as possible.

- Open and Transparent Government

- Committee hopes to increase transparency and communication through their work and the work of government. It was noted that Committee can at times visit communities during or on the heals of Governments engagements on similar topics.
- Committees encourages a collaborative discussions occur between staff at the assembly and Government departments in an effort to ensure that the timing of these engagements can be more meaningful for both government and committee. It was noted that engaging too quickly after or before one another impacts the willingness of community participation into important policy matters.

- Federal Engagement

- Committee wishes for regular members to be more involvement with federal engagement efforts made by Cabinet. This includes the ability to meet with federal ministers when they visit constituencies.
- Committee also wishes for better communication from Executive Council on all Federal-Provincial-Territorial (FPT) engagements, particularly with bi-lateral or multi-lateral government agreements. FPT and Bi-lateral meeting agendas should be shared in advance of these meetings so that Committee can contribute to the engagements.
- Additionally, Committee should be able to participate in FPT engagements, particularly when federal and provincial Ministers are visiting the Northwest Territories.
