

Food Security

The Northwest Territories (NWT) has the second highest rate of food insecurity in the country.

Concerns about existing food security issues in the NWT are being exacerbated by the COVID-19 pandemic, inflation and environmental - emergency events.

19th Assembly's Food Security Mandate

ITI has been tasked to lead departments to:

Increase food security through locally produced, harvested, and affordable food:

- Support the development of the food industry
- Increase country food harvesting
- Work with Canada to increase the flexibility of the Nutrition North Program to better serve NWT residents

Increased local food production can support the GNWT's goal to improve food security across the territory

Food Security: The Need for a Coordinated and Strategic Approach

- The federal Food Policy for Canada is coordinating Food Security efforts, a coordinated GNWT approach will allow for strategic application to federal and potentially NGO funds.
- Both businesses and communities have limited resources but require support to increase food security.
- GNWT Departments are working together to create pathways for food security support through the Interdepartmental Food Security Working Group.



Food Security: Pandemic Focus

- Departments worked to address issues around Food Security
- Specific work with other governments occurred to identify potential avenues for the GNWT to advance food security collaboratively.
- Since the pandemic the federal focus has been on food charity for Canadians experiencing food insecurity with the Emergency Food Security Fund, Surplus Food Rescue Program and the Rural and Northern Capacity Fund

Nutrition North Update

- In April 2020, Canada launched the Harvesters Support Grant, co-developed with IGO partners to improve access to traditional foods and lower the high costs of hunting and harvesting. The Harvesters Support Grant is delivered through Nutrition North Canada.
- In July 2021, Canada announced four new appointments to the Nutrition North Advisory Board, all of whom are northerners, and three of whom are Inuit women.
 This includes a member from the NWT, Dr. Sarah Jane Cook.
- In August 2021, Canada responded to requests from the Premier and NWT communities for the program to be expanded to communities with seasonal access. Five additional NWT communities are now eligible for the Nutrition North retail subsidy.



ITI Update

- Working with Commercial operators to expand their production
- Start engagement on the New Policy Framework Agriculture and Agri-Food Canada (replacing the CAP 2023)
- SCEDE update in new year re implementation and amendments under CAP for food security programming
- Building of CFIA approved Hay River Fish Plant





Notice of Motion 37-19(2): Creation of a Northwest Territories Food Security Strategy

- Tabled on June 4th 2021, the Motion included requests that the GNWT:
- Prioritize the development of a Food Security Strategy and coordinate this with the income assistance review
- Identify principles for NWT food security
- Review the effectiveness of all Government of the Northwest Territories food security funding programs
- Implement community based food security coordinators in the most food insecure communities
- Remove all of its legislative regulatory barriers to facilitate regional sharing of harvested meat or other food products
- Pilot an initiative immediately that improves the effectiveness of community-based freezers, kitchens, and food preparation and food storage programs
- Develop and implement tracking of local food production, and set targets
 - Create a clear point of contact in the Government of the Northwest Territories to track community concerns and advance initiatives



Notice of Motion 37-19(2): Creation of a Northwest Torritories Food Security Strategy

Response: Tabled Nov 22nd 2021

The GNWT is supportive of the intent behind this Notice of Motion and commits to continued interdepartmental collaboration to advance the principles behind it.

 This includes a commitment to have Departments work together on the development of a strategic approach to food security, including staff a Senior Advisor position that will continue the momentum created during 2020-2021





Next Steps

- Ministers have agreed to establish the Senior Advisor position at HSS, as part of the Anti-Poverty unit.
- Development of a strategic approach to food security will take place alongside renewal of the Anti-Poverty Action Plan, which ends in 2022.
