Please note that any written changes made to the content of the affidavit page(s) must be checked marked on either side of the change and initialed by both the witness, Notary Public or Commissioner for Oaths at both check mark locations.

A Notary Public is required if the document is signed outside the Northwest Territories.

NOTE: The Witness and the Commissioner for Oaths or the Notary Public cannot be the same person and any changes made to this Affidavit Page are required to be initialled by both the Witness and the Commissioner for Oaths or the Notary Public under the Evidence Act.

- 5. Your witness **prints** his/her full name at the top of this page, **swears** to the truth of this affidavit before a Commissioner for Oaths or Notary Public, and **signs** at the bottom right hand side of this page.
- 6. The Notary Public or Commissioner for Oaths must fill out the jurat on the **left hand side of the page**, by dating, and signing it. They must then print his or her name where indicated and **attach their Notarial seal**. **The date their commission expires must be indicated**. If the official has no expiry date for his/her appointment, then they put in the **words "Does not expire" or "Not applicable"**.
- 7. Ensure all fees have been enclosed and return **both lease documents to this office.** The duplicate lease will be returned to you once it has been executed on behalf of the Government of the Northwest Territories.
