MAKE OATH AND SWEAR THAT:

INTRODUCTION

1. I am the Member of the Legislative Assembly for the constituency of Nunakput in the Northwest Territories.
2. I understand that a Member whose principal residence is not within commuting distance of the capital may be reimbursed for:
 - (a) the actual rent for rental accommodation in the capital, and other authorized expenses;
 - (b) the actual cost of hotel accommodation in the capital, and other authorized expenses; or
 - (c) the actual rent for a secondary residence established within commuting distance of the capital, and other authorized expenses,

provided that the Member complies the *Legislative Assembly and Executive Council Act*, the *Indemnities, Allowances and Expense Regulations* and provides to the Clerk of the Legislative Assembly a Statutory Declaration, in the form approved by the Board of Management.

3. I have reviewed and fully understand the *Legislative Assembly and Executive Council Act*, the *Indemnities, Allowances and Expense Regulations* and the Legislative Assembly's policies as each concern residency reimbursements, and this Statutory Declaration is given pursuant to the terms thereof.

PRINCIPAL RESIDENCE

4. That I currently reside at _____ Tuktoyaktuk, NWT, legally described as Lot _____ Block _____ Plan _____ Tuktoyaktuk, and have resided there continuously since October 28, 2021 (my "**Ordinary Residence**").

That when I am not required to be in Yellowknife for Sessions of the Legislative Assembly, meetings of its Committees or other business as a Member my Ordinary Residence is the place where I normally reside, sleep, prepare and have meals, and maintain my clothing, furnishings and effects, and it is where people would know to ordinarily contact me when

I am not required to be in Yellowknife for Sessions of the Legislative Assembly, meetings of its Committees or other business as a Member.

6. That I consider my Ordinary Residence, to be my home and when I refer to home I am referring to this place of residence.
7. That I own my Ordinary Residence and a copy of my certificate of title is attached to this document as **exhibit "A"**.
8. That attached as **exhibit "B"** is a copy of my municipal tax assessment for 2023.
9. That I pay for the following utilities at my residence:
 - (a) Water
 - (b) Power
10. That my spouse as, defined in the *Family Law Act*, resides with me at this address.
11. That I have no dependents that reside with me at my Ordinary Residence.
12. That attached as **exhibit "C"** to this document are copies of the following utility bills: Utilities specified above.

GENERAL

13. I hereby undertake to advise the Clerk of the Legislative Assembly, in writing, within 30 days of any change of my residency that would in any way effect the calculation of an allowance pursuant to the *Legislative Assembly and Executive Council Act* or the *Indemnities, Allowances and Expense Regulations*, including any change of the:
 - (a) address of my Ordinary Residence;
 - (b) ownership or possession of my Ordinary Residence; or
 - (c) ownership or possession of a secondary residence within commuting distance of the capital.
14. I hereby acknowledge and agree that:
 - (a) I cannot rely upon the notice provided in section 13 of this Statutory Declaration as a bar to any recovery action undertaken by the Legislative Assembly or as a defense to the improper receipt of any of the aforementioned allowances;
 - (b) I have an obligation to provide a current and accurate Statutory Declaration to the Law Clerk for filing in the Legislative Assembly that accurately reflects my residency; and


(c) The Clerk of the Legislative Assembly and their staff or delegates may make such inquiries as necessary to verify the contents of this Statutory Declaration and the exhibits attached hereto, and I further undertake to sign any and all reasonable releases requested by the Legislative Assembly for the verification of this document and its attached exhibits.

15. I understand that should I make false statements in this Statutory Declaration, or improperly receive any allowances that I am not entitled to:

- (a) I will be responsible for reimbursing the Legislative Assembly, with interest, any allowances received that I was not entitled to;
- (b) the Board of Management could refer my matter to the Integrity Commissioner for an independent investigation;
- (c) I could be subject to sanction by the Members of the Legislative Assembly, including having my seat declared vacant; and
- (d) I could be subject to civil and criminal sanctions.
