### Oral Question 1311-19(2): Speech Language Pathology Services

This letter is to follow up to the Oral Question you raised on February 7, 2023, regarding Speech Language Pathology Services.

The following wait time information for each Rehabilitation service is current as of December 31, 2022 and reflects the wait time for patients in the last 3 month period (September 1, 2022 – December 31, 2022). The wait time starts when a referral for rehabilitation is received by the Health and Social Services Authority and ends when the patient receives rehabilitation services. The wait time is affected by several things, including, the priority assigned to the referral and the location of the referral (e.g. some services and teams may have longer wait times because they receive more referrals or because they have vacant positions).

Rehabilitation Services uses a Wait Time Priority Tool to determine which patients need to be seen more urgently. Priority 1 and 2 clients have a more urgent need for services and Rehabilitation services aim to see these clients more quickly. The wait time for Priority 1 and 2 patients is listed below, and reflects that patients with urgent rehabilitation needs are seen quickly. Priority 3 to 5 clients tend to be a larger group of patients and often wait longer to receive services, as reflected in 75<sup>th</sup> percentile wait time (75<sup>th</sup> percentile wait time means that 75% of all patients seen in the last 3-month period waited less than this time and 25% of patients waited longer).

#### Wait Time categories defined below:

EMR Priority	Rehab Priority	Threshold (time frame to be seen within)	Description
Urgent	P1	72 hours	Immediate intervention is required to prevent deterioration or exacerbation of condition, severe activity limitation
Urgent	P2	2 weeks	Urgent intervention is required to allow individuals to function safely and independently in their environments.
Semi- Urgent	Р3	6 weeks	Intervention is needed in order to prevent deterioration in function and to improve impact on self, home, work, school.
Routine	P4	10 weeks	Intervention is intended to improve quality of life and maximize client's ability to participate in home, work, school and leisure activities.
Routine	P5	5 months	Chronic disease management or non-acute exacerbations that require monitoring to ensure continuation of functional activities and ability to participate.
