MESSAGE FROM THE SPEAKER



As we close another year at the Legislative Assembly, I am reminded of the importance of collaboration, cultural inclusion, and our commitment to the people of the Northwest Territories.

This year, we worked hard to foster an

inclusive Assembly. Our decision to incorporate traditional guiding words to open our sittings, conducted in the diverse languages of our territory, marks a new era of doing things differently. We are dedicated to ensuring that the Legislative Assembly is a place where all voices are heard and respected. In particular the voices of Indigenous peoples.

As I reflect on the past year, I am proud of the resilience and adaptability shown by residents of the Northwest Territories in facing wildfires that affected so many of our communities. These fires compelled difficult decisions, including postponing the Territorial General Election to ensure the safety and well-being of residents. With more than 65% of the population displaced, proceeding with the election as scheduled would have been impractical and unsafe. This delay was n necessary logistically and also to ensure a fair and accessible electoral process.

Despite these challenges, the Assembly's work continued. Among notable achievements, I am particularly proud of the assent of Bill 85, the United Nations Declaration on the Rights of Indigenous Peoples Implementation Act. This Act positions the Northwest Territories as the second province or territory in Canada to pass such legislation.

It sets the UN Declaration as a framework for reconciliation between the territorial Government and Indigenous Governments. The Act requires that a statement of consistency be tabled with each bill introduced in the Assembly to confirm it aligns with the UN Declaration.

I want to acknowledge the essential role of our interpreters, who ensure that our proceedings are accessible to all residents, regardless of the language they speak.

In a particularly emotional moment this year, I put my name forward for Speaker. Many people encouraged me to consider the role, noting the need for a more respectful tone of debate in the chamber. As I stated during my announcement, while conflict between members in consensus government can be productive, confrontation is not. It drains energy and backs people into a corner. Our constituents deserve better. This Assembly needs somebody who is more than a referee – it needs a coach; someone to help members understand their roles and procedures, and how they can best work on behalf of their constituents.

As we move forward into the new year, I remain committed to fostering collaboration, transparency, and inclusivity. It is my honour to serve as Speaker, and I look forward to welcoming our residents and visitors to the territory to our Assembly, the true place of the people, where every voice is heard, respected, and valued.

MESSAGE DU PRÉSIDENT

La fin d'une autre année à l'Assemblée législative est l'occasion de me rappeler l'importance de la collaboration, de l'inclusion culturelle et de notre engagement envers la population des Territoires du Nord-Ouest (TNO).

Cette année, nous nous sommes efforcés de favoriser l'inclusion au sein de l'Assemblée. La décision d'ouvrir nos travaux par quelques mots d'orientation prononcés dans les diverses langues officielles du territoire marque le début d'une nouvelle façon de procéder. Nous sommes résolus à faire de l'Assemblée législative un lieu où chaque voix puisse être entendue mais aussi respectée, et tout particulièrement celles des peuples autochtones.

Alors que l'heure est au bilan, je suis fier de la résilience et de l'adaptabilité dont ont fait preuve les Ténois face aux feux de forêt qui ont touché nombre de nos collectivités. Ces feux nous ont appelés à prendre des décisions difficiles, y compris le report de l'élection générale territoriale, pour la sécurité et le bien-être de nos résidents. Étant donné que plus de 65 % de la population était déplacée à l'époque, la tenue de l'élection n'aurait pas pu se faire dans des conditions pratiques ni sécuritaires. Une telle prorogation était donc nécessaire, tant du point de vue de la logistique que de l'équité et de l'accessibilité du processus électoral.

En dépit de ces défis, l'Assemblée législative a poursuivi ses travaux. Je suis particulièrement fier de compter, parmi nos réalisations marquantes, la sanction du projet de loi 85 – Loi de mise en œuvre de la Déclaration des Nations Unies sur les droits des peuples autochtones – grâce auguel les TNO sont devenus la deuxième administration canadienne (province ou territoire) à adopter un tel texte législatif. Cette loi désigne la Déclaration des Nations Unies comme cadre de travail pour la réconciliation entre le gouvernement territorial et les gouvernements autochtones. Elle prévoit ainsi qu'un énoncé de compatibilité soit fourni lors du dépôt de chaque projet de loi à l'Assemblée, dans le but de confirmer la conformité de celui-ci à la Déclaration des Nations Unies.

Je tiens aussi à saluer le rôle essentiel de nos interprètes, qui s'assurent de rendre accessibles nos travaux à l'ensemble des résidents, indépendamment de leur langue.

Lors d'un moment particulièrement émouvant l'année dernière, j'ai proposé ma candidature au poste de président de l'Assemblée législative. Plusieurs personnes m'avaient encouragé dans cette voie-là, en soulignant la nécessité de faire régner un ton plus respectueux lors des débats en Chambre. Comme je l'ai indiqué à l'occasion de ma prise de fonction, les conflits entre les députés d'un gouvernement de consensus peuvent être productifs, mais pas la confrontation, qui nous vide de notre énergie et nous pousse dans nos retranchements. Nos électeurs méritent mieux que cela. Cette Assemblée a besoin de plus qu'un arbitre; elle a besoin d'un « entraîneur » capable d'aider les députés à comprendre leurs rôles respectifs et les procédures qu'ils doivent respecter, ainsi que la façon dont ils peuvent servir au mieux leurs électeurs.

À l'approche de la nouvelle année, je reste déterminé à promouvoir la collaboration, la transparence et l'inclusion. Je suis honoré de pouvoir servir à titre de président de l'Assemblée législative et je me réjouis d'accueillir nos résidents et nos visiteurs dans l'enceinte de la véritable « place du peuple », où chaque voix est entendue, respectée et valorisée.

UNDRIP LEGISLATION ACCOUNTABILITY

The Northwest Territories became the second province or territory to pass legislation to implement the UN Declaration in Canada. Bill 85: *The United Nations Declaration on the Rights of Indigenous Peoples Implementation Act* requires the Government of the Northwest Territories (GNWT) to table a statement of consistency with each bill to confirm it is consistent with the UN Declaration, and it Is used as a framework for reconciliation between the territorial Government and Indigenous Governments.

The Legislative Assembly created the *Consensus Government in the Northwest Territories Guiding Principles and Process Conventions*, which guides how co-developed land and resource legislation, is introduced, considered, and enacted. This convention is a key feature of our unique Consensus government. It creates the necessary space for Indigenous Governments in the Legislature and provides an avenue for Indigenous Governments' participation at all stages of the legislative process.




DELAY OF THE TERRITORIAL GENERAL ELECTION DUE TO ONGOING WILDFIRES

The Speaker of the Northwest Territories Legislative Assembly, Honourable Frederick Blake Jr., received a recommendation from the Chief Electoral Officer (CEO) to delay the Territorial General Election due to ongoing wildfires.

Members of Caucus supported the recommendation, which led to the decision to recall the Assembly on August 28, 2023, to pass legislation delaying the election until November and approving additional wildfire-related funding. The Speaker emphasized safety concerns as the driving factor behind this decision.







SWEARING-IN CEREMONY OF MEMBERS OF THE 20TH ASSEMBLY

Members of the 20th Northwest Territories Legislative Assembly were officially sworn in on Friday, November 24, 2023.

Before assuming their duties, each Member takes the Oath of Office before the Commissioner of the NWT. This includes the Oath of Allegiance under the Constitution Act, 1867, and the Oath of Loyalty to the people of the Northwest Territories as outlined in the Legislative Assembly and Executive Council Act.





The first orders of business for the committee included receiving public briefings on the Indigenous Employment Policy, and evacuation support programs. In February 2024, **Bill 3:** *Carbon Tax Repeal Act* was referred to Committee for review.

During the 20th Assembly, Committee is required to conduct statutory reviews of the *Northwest Territories Heritage Fund Act* and the *Cannabis Legalization and Regulation Implementation Act*.

In February 2024, **Bill 2**: *Missing Persons Act* was referred to Committee for review. The Missing Persons Act would allow RCMP, with court approval, to access many types of records, such as information found on cell phones and other electronic devices, but also records about school attendance, employment, personal health and finances. Monfwi MLA Jane Weyallon Armstrong, who chairs the committee, highlighted the importance of this legislation given a number of outstanding missing persons cases in the N.W.T. "It will benefit the family and friends out there".

The establishment of the Board emphasizes the responsibility that Members have for the general administration of the Legislative Assembly and confirms the independence of the Legislature from the Executive branch of government.

The Speaker has the primary responsibility for the services and programs required by the Assembly and its Members. Its responsibilities include, but are not limited to:

- compiling and approving the annual budgetary estimates for the operation of the Legislative Assembly
- reviewing Legislative Assembly expenditures
- arranging for adequate space for the Assembly operation
- establishing the organization and staff of the Legislative Assembly
- administering the indemnities, allowances, expenses and benefits to Members
- setting the regulations and policies for all services to be provided to Members.





The Legislative Assembly's Board of Management is established under the *Legislative Assembly and Executive Council Act.*



CAUCUS

All Members of the Legislative Assembly (MLAs) form the Caucus, which ensures the success of consensus government in the NWT. Caucus allows all MLAs, regardless of their roles, to work together on broad strategic goals and pressing issues facing the territory.

Caucus meetings are confidential, fostering open, honest discussions without the constraints of Cabinet or committee solidarity. Even the Speaker and Premier contribute as equal participants unless they're required to speak in their official capacities.

Following each election, the Caucus comes together to define strategic priorities for their four-year term, as seen with the "Priorities of the 20th Assembly." The Chair and Deputy Chair are selected from non-Cabinet, non-Speaker MLAs to ensure impartial leadership.





2023-2024

Statutory officers (also called independent officers) play an important role in helping Members hold the government accountable. They help Members assess government programs, investigate complaints, examine procedures, and monitor performance. Statutory officers serve for fixed terms that vary according to the laws governing each position. These officers are appointed by, and report to, the Legislative Assembly.

THERE ARE SEVEN STATUTORY OFFICERS OF THE NORTHWEST TERRITORIES LEGISLATIVE ASSEMBLY:

OFFICE OF THE CHIEF ELECTORAL OFFICER

Elections NWT conducts and administers general elections, by-elections, and plebiscites in the Northwest Territories. Its principal mandate is to educate, inform and empower all eligible electors and candidates in the Northwest Territories to exercise their democratic rights outlined in the Canadian Charter of Rights and Freedoms, so that they may participate fully in the election process.



OFFICE OF THE LANGUAGES COMMISSIONER

The Languages Commissioner's duty is to ensure that institutions of the Legislative Assembly and the GNWT departments, boards, agencies, and courts follow the duties laid out in the *Official Languages Act* and the provisions of any other Act or regulation relating to the status or use of official languages.

OFFICE OF THE HUMAN RIGHTS COMMISSION

The *Human Rights Act* came into force on July 1, 2004. The Act recognizes that in the Northwest Territories every individual is free and equal in dignity and rights, without regard to their race, colour, ancestry, nationality, ethnic origin, place of origin, creed, religion, age, disability, sex, sexual orientation, gender identity, marital status, family status, family affiliation, political association or social condition and without regard to whether he or she has had a conviction for which a pardon has been granted.

OFFICE OF THE EQUAL PAY COMMISSIONER

The right to equal pay for work of equal value is created by section 40 of the *Public Service Act* and applies to public service employees. It requires that there be no differences in the rate of pay between male and female employees who perform work of equal value in the same establishment. The Equal Pay Commissioner receives complaints from employees who believe that their right to equal pay for work of equal value has been violated.

None of this would be possible without the commitment and professionalism of our staff. I look forward to continuing our work together as we build on this strong foundation for the years ahead.










PAGE PROGRAM

YOUTH PARLIAMENT

constituencies. The former Commissioner, Honourable Margaret Thom, opened and closed the session, making the experience even more memorable.





MACE TOUR

The 2024 Mace Tour celebrated Northern culture and connected communities across the Northwest Territories. Led by Speaker Shane Thompson, the tour visited constituencies in Inuvik and Nunakput, including Sachs Harbour, Paulatuk, Tuktoyaktuk, and Ulukhaktok. As a former soccer coach, Speaker Thompson held soccer clinics in each community, promoting youth engagement and encouraging physical activity. He also donated soccer balls to local schools, leaving a lasting impact.

The tour aimed to enhance public understanding of Consensus Government, the symbolism behind the Mace, while also fostering cultural

pride, community involvement, and youth participation in sports.

In celebration of Indigenous Language Month, the Northwest Territories Legislative Assembly added a Tłįchǫ language version to its self-guided audio tour. Available on the "Smartify" app, the 30-minute tour, narrated by Elder and legislative interpreter Maro Sundberg, explores NWT history, the Mace, and consensus government. This initiative supports language revitalization and reconciliation.

The Legislative Assembly upgraded its chamber broadcast system to accommodate 16 interpreters, providing real-time translation into 8 official Indigenous languages during sessions. This marked a record for simultaneous Indigenous language interpretation. The live stream now includes floor audio, broadcasting all spoken languages. The Assembly's YouTube channel was revamped with separate playlists for each language, making translated videos easily accessible. Additionally, 317 French translation requests were made, translating over 129,000 words through Broca, in collaboration with the Francophone Affairs Secretariat.

MISSING AND MURDERED INDIGENOUS WOMEN AND GIRLS MONUMENT

The Legislative Assembly unveiled the Missing and Murdered Indigenous Women and Girls monument in front of the Legislative Assembly building on October 4, 2023. Thoughtfully designed by Inuvialuit artist Myrna Pokiak, the monument serves as a sacred place for families to sit with their loved ones, honour those who have fallen, and recognize the injustices experienced by Indigenous women, girls, and 2-spirited people. It is a place to share in the healing journey and will remain a permanent fixture that will raise awareness of this ongoing national tragedy.

- The Red Parka symbolizes Northern culture, honouring the Missing and Murdered Indigenous Women and Girls.
- The Dene Drum represents the Dene.
- Feathers formed into an infinity symbol represent the Metis.
- The Qulliq, an oil lamp, symbolizes the Inuvialuit and Inuit people, also serving a functional purpose
- The infinity is adorned with hearts symbolizing the Native Women's Association of the Northwest Territories efforts for awareness on Missing and Murdered Indigenous Women and Girls.

DOME LIGHTING

The Legislative building has an external lighting system that allows the building Domes to be lit in a single colour wash (including blackout) or multiple colours (northern lights). This lighting not only helps highlight the building's architectural features but can help the Legislative Assembly to participate in celebrations and commemorations in the wider community, strengthen public engagement, and promote the Northwest Territories.

During the sunny summer months of June and July, Northerners experience nearly 24 hours of daylight, known as the 'midnight sun.' Any special lighting requests during this period will not be considered, as they will not be effective in the continuous daylight.


