EXECUTIVE SUMMARY

In 2019, Members of the 19th Legislative Assembly committed to ensure that government procurement maximizes benefits for NWT residents and businesses. After much work to review the procurement policies through an independent panel and much discussion about their recommendations, the GNWT released a procurement review report in August 2023 that included an implementation plan with actions that it would take to improve government procurement policies and practices. Actions to appropriately assess this work and make the necessary changes take time and careful attention. Since the last report, 8 have been completed, 8 are in progress and 2 have yet to start as they do not have current procurement implications. The 20th Legislative Assembly will continue to focus on procurement as it is a key mechanism to provide benefits to NWT businesses and residents.


INTRODUCTION

In August of 2023, a procurement review report was published that summarized the work of the 19th Legislative Assembly and included an update of where the GNWT is with its procurement data and the actions that were left to be completed. A significant amount of work was completed and an update to each action item is included below along with an update of the GNWT's procurement data for 2023-2024.

An Update on our Contracts Reporting

Contracts issued to NWT businesses

The contract data includes reportable contracts (i.e., does not include contracts that are not publicly reported due to legislative, security, or confidentiality concerns) for all GNWT departments and Housing NWT. The contracts included are greater than \$10k for services and \$25k for goods in accordance with the limits in the Financial Administration Manual.


Construction Contracts

Construction contracts in 2023-2024 accounted for \$150 million and the large majority was awarded to NWT Businesses as follows:

- 93% was awarded to NWT companies (89% BIP registered and 4% NWT).
- 7% was awarded to non-NWT companies.

Summary of procurement data 2021-2024

Amounts to NWT Businesses

Looking at the three years of contract data for GNWT departments and Housing NWT, the contract amounts by value to NWT businesses account for on average 72% of the total. When you take into consideration where bids were not received by any NWT businesses and goods and services that are not available in the NWT (such as software licensing) that number is higher.

Overall Contract Amounts

In 2023-24, the total amount by value to NWT businesses only accounted for 61% which was a decrease of 15% from the prior year and the overall dollar value decreased by \$22.8m. The overall increase in contracts between 2023-24 and 2022-23 was \$67m. Several large contracts issued in 2023-24 including a multi-year contract for dental plan administration for employee benefits, fuel purchases and wildfire emergency related contracts were issued to non-NWT businesses and make up a portion of this decrease to NWT businesses as well as accounting for the large overall increase from the prior year.

Change Orders

In 2023-24, change orders increased from the prior year by \$46m or 82%. This difference was largely due to change orders on fuel supply contracts and fire suppression or emergency related contracts.).
