22-20(1) Extended Adjournment of the House to May 23, 2024

Moved by the Member for Yellowknife North:

NOW THEREFORE, I MOVE, seconded by the Honourable Member for Hay River North, that notwithstanding Rule 2.1, when the House adjourns on Thursday, February 29, 2024, it shall be adjourned until Thursday, May 23, 2024;

AND FURTHER, that any time prior to May 23, 2024, if the Speaker is satisfied after consultation with the Executive Council and Members of the Legislative Assembly that the public interest requires that the House should meet at an earlier time during the adjournment, the Speaker may give notice;

AND THEREUPON, the House shall meet at the time stated in such notice and shall transact its business as it has been duly adjourned to that time.

The motion was CARRIED.

## 23-20(1) Call to Uphold Human Rights in Gaza

Moved by the Member for Great Slave:

NOW THEREFORE, I MOVE, seconded by the Member for Yellowknife North, that this Legislative Assembly condemn all acts of antisemitism and anti-Palestinian racism in our territory;

AND FURTHER, that this Legislative Assembly calls upon the Premier to write a letter to Prime Minister Justin Trudeau, Minister of Foreign Affairs Melanie Joly, and Permanent Representative of Canada to the United Nations Bob Rae, that will call upon the Canadian Government to:

- call for an immediate and effective ceasefire and halt to violence by both Israel and Hamas;
- advocate for the immediate release of all hostages;
- advocate for, and provide funds for unhindered access for humanitarian aid for all those in need in Gaza; and
- take all actions necessary to fully uphold its obligations under the Genocide Convention;

AND FURTHERMORE, that the Northwest Territories Member of Parliament, Michael McLeod, receive a copy of this letter;

AND FURTHERMORE, that the Government of the Northwest Territories provide a response to this motion within 120 days.

Motion to Amend Call to Uphold Human Rights in Gaza Motion 23-20(1)

Moved by the Member for Yellowknife Centre:

NOW THEREFORE, I MOVE, seconded by the Member for Mackenzie Delta, to amend Motion 23-20(1): Call to Uphold Human Rights in Gaza, by inserting the words "in an accountable method that demonstrates transparency which ensures Canadian aid, given by the Canadian Government, goes direct to support humanitarian need" to the third bullet point in the second clause, after the word "Gaza", such as the bullet point reads:

advocate for, and provide funds for unhindered access for humanitarian aid for all those in need in Gaza, in an accountable method that demonstrates transparency which ensures Canadian aid, given by the Canadian government, goes direct to support humanitarian need,"

The motion to amend Motion 23-20(1) was CARRIED.

23-20(1) Motion to Amend Motion 23-20(1): Call to Uphold Human Rights in Gaza (As Amended)

Moved by the Member for Yellowknife Centre:

NOW THEREFORE, I MOVE, seconded by the Member for Mackenzie Delta, to amend Motion 23-20(1): Call to Uphold Human Rights in Gaza, by inserting the following clause after the second whereas clause:

AND WHEREAS this Assembly, recognizes through the Government of Canada's designation, that Canda has listed Hamas as a terrorist entity under the Criminal Code since November 2022.

The motion to amend Motion 23-20(1) was CARRIED.
